Under the terms of the Access to Medical Reports Act 1988

You have the right to withhold your consent for Birmingham Aeromedical Centre to apply to your healthcare practitioner (your family doctor, hospital specialist or allied healthcare practitioner) for medical information about you. If you give your consent, you have the right to see the information before it is provided to Birmingham Aeromedical Centre. You will have 21 days from the date you are notified that medical information about you has been requested in which to ask your healthcare practitioner to let you see the medical report or records to be provided. Your healthcare practitioner will tell you if you cannot see any part of the report or records for professional medical reasons. If you are given access to your medical information, your healthcare practitioner will not send it to Birmingham Aeromedical Centre until they have your consent. If you regard any information in the report or records as incorrect or misleading they are not required to make any amendment, but in these cases your healthcare practitioner will invite you to prepare a written statement on the disputed information which will be attached to the medical report or records sent to Birmingham Aeromedical Centre. Subject to the provision of the Act, you have the right to see your medical information for up to 6 months after it has been sent to Birmingham Aeromedical Centre.
